	Therese Rednor, DAC Chair welcomed members to the meeting
	and introduced guests.
Information	High School Reimagined Update by Dr. Kym LeBlanc-
	Esparza
	Dr. Kym started this conversation in another district 12 years ago.
	Report cards look much the same as several generations ago.
	There is a focus on what we want a Jeffco graduates resume to
	look like. Jeffco has a goal of a CTE pathway in every high
	school. 1500 students in CTE, with 1200 on the waiting list.
	Electives are consistently what students say they are most
	excited about, but the first to get cut with budget reductions.
	Students also report that with so few slots for electives, they have
	to be selective about their choices. A steering committee
	engaged in three day stakeholder meeting. They found that
	durable skills crossover into academic, workforce, and personal
	skills. Draft learner goals updated to reflect core academic skills,
	life readiness skills, and workforce skills. One way to give
	students more CTE experience and more opportunity to take
	electives is to combine complementary classes, like the
	Geometry and Construction class currently on offer. The progress
	of integrating classes is called compacting. Q: Is there a budget
	for this effort? A: Some elements will have their own budget, and
	some elements do not have associated costs, but there is no
	High School Reimagined Budget. Funds may be differently
	allocated but not increased. Q: Have you visited charter schools
	who may already be implementing aspects of this plan? A: Yes,
	we have reached out and interviewed many school administrators
	to get their input. Q: How will we measure if the students are
	obtaining the skills identified in the presentation? A: Testing will
	give us some answers, and feedback from the community will tell
	us if they are graduating with the skills required. Q: What is your
	timeframe for implementation? A: 3-5 years to do well.

What is the purpose of the DAC?

The Colorado District Accountability Committee (DAC) is established at the district level in Colorado to promote accountability and provide community input regarding district-wide educational policies and programs.

The DAC plays an essential role in ensuring transparency, engaging the community, and supporting the continuous improvement of schools within the district.

CO Rev Stat § 22-11-302 (2016)

Why we do this?

We are the voice of our schools and community.

- We collaborate and work with district staff.
- We advise the Board on district matters in which we have responsibility.
- We engage with the community for input.

- Charter school reviews






- Board decisions affect all aspects of our schools!

- 69,000 kids; 14,000 staff; and the community at large.



Articulation Area Representatives are local SACs' direct voice on the DAC.

District surveys including **Family School Partnerships** and **Make Your Voice Heard,** as well as the **Healthy Kids Colorado** and **Teaching and Learning Conditions Colorado** surveys, drive recommendations from the FSCP Subcommittee.



Our Board listens to our recommendations.

Overall DAC Goals for 2023-2024

- Give greater voice to our schools through SACs into DAC processes and recommendations.
- Work to support alignment of district and school UIPs (Unified Improvement Plans).
- Support SACs by ensuring they have the tools and resources needed to operate in collaboration with school staff.
- Empower and encourage all families and communities to actively partner with schools to promote student success.
- (Other goals to be determined by the DAC and the school board.)



How DAC Operates

- Monthly DAC meetings on the 3rd
 Tuesdays, 5:30-8:30 p.m. (with some exceptions) August through May, in Ed Center Board Room.
- Bylaws & Roberts Rules of Order.
- Monthly meetings of Executive Committee (Chair, Vice Chair, Secretary, and subcommittee chairs).
- Subcommittee meetings (as determined by chairs).
- Meeting(s) with Board of Education, with DAC represented by Executive Committee.

What happens when asked to call a motion?

Calling a motion using Robert's Rules of Order is a way to suggest an action or decision during a meeting. Here's how you can do it:

- 1. State your amendment clearly and wait for someone else to second it, just like before.
- 2. The chairperson will allow discussion on the amendment. Once everyone has had a chance to speak, there will be a vote on the amendment.
- 3. If the amendment is accepted, the chairperson will ask if there are any more amendments. If not, the discussion will go back to the original motion.
- 4. The chairperson will then call for a vote on the original motion.
- 5. Listen carefully to the chairperson and vote accordingly. The chairperson will announce the result of the vote. If the majority of people vote in favor, the motion is passed. If not, it is not passed, and the meeting will move on to the next item of business.

Remember, calling a motion aims to express your ideas and influence the decisions made during the meeting. By following these steps and being respectful, you can effectively use Robert's Rules of Order to participate in meetings and make your voice heard.

General Expectations



Meeting minutes, agendas, and relevant materials will be sent to you 1 week prior to each DAC meeting.



You are expected to attend each meeting, prepared to discuss/vote.

General rule of thumb: Review at one meeting, vote at next one.

However... rules may be waived (by vote), in cases when expediency is required. We will inform you prior to the meeting.



There is generally more to discuss than we have time for.

Participate in subcommittees: This is where much of the work happens and where you have the most direct influence.

Any additional input can be emailed to the chairs



Members engage in discussions at meetings and ask questions.



Your "mileage may vary," but you will likely spend ~4-6 hours a month on DAC-related activities.

Attendance and Subcommittees

- Attendance is expected and required at monthly DAC meetings.
 - Let the Chair, Vice Chair, or district staff know if you can't attend.
 - Two unexcused absences could result in your removal and replacement.
- DAC Members are appointed by BOE for two-year terms.
 - Can apply for renewal as many times as you want.
 - Stakeholder groups (JCEA, JCAA, JESPA, PTA) may recommend their own members.
- You are expected to be an active member of at least one subcommittee (except AARs).
 - There are 4 subcommittees: DUIP, Budget, FSCP, and Charter Review.
 - Meeting frequency and times are at the discretion of Subcommittee Chairs.



Code of Conduct

Be PRESENT, PREPARED, ENGAGED, and ON TIME.

Read our Bylaws

Be respectful: Thoughtful debate is great; personal attacks are not.

No filibustering – use a Dissenting Opinion

Be open-minded.

Be clear when you are representing DAC or when you are speaking for yourself.

Do not use your position in DAC for personal benefit.

Disclosure and/or recusal are expected in the rare event of a conflict of interest.

Where to start!

- Pick a Committee; this is where the DAC work happens.
- If you are an AAR, exchange information with your AAR partner.
- Put the DAC meeting dates in your calendar.
- Review the school list and contact information provided.
- Review the CDE Checklists for the DAC and for SACs.
- Review the School Business Activity Calendar.

Plans annual trainings at beginning of year (AARs, SACs, DAC); makes recommendations about improving FSCP in the district; supports AARs and SACs.

Meets 5:30 p.m. on 1st Tuesdays virtually on Teams.

DAC Charter Review Subcommittee

Chair: Jeff Baucum

Reviews charter school applications and renewals. Directly advise the DAC on community recommendations around charter approvals or renewals.

Meets as needed when charter applications or renewals are received by the district.

Articulation Area Representatives (AARs)

- AAR Chair: Carsten Engebretsen
- Special meetings of all AARs may be arranged, if needed.
 - AARs are the voice of local schools on the DAC to work with SACs and principals to form a dialogue between DAC and the SACs.
 - 2 representatives for each high school articulation area
 - 3 representatives for charter schools
 - 2 representatives for option schools
 - AARs are expected to work closely with their schools' SACs to share information and communicate needs to DAC.

Board Policy KB – Family-School-Community Partnership

"The district recognizes that family-school-community partnerships are essential for improved student achievement, school success, and a positive learning environment. ... The following research-based components, recently updated by the National PTA, will be used as a comprehensive and coordinated framework to guide family-school-community partnership work:

Standard 1: Welcome All Families - The district and its schools treat families as valued partners in their child's education and facilitates a sense of belonging in the school community.

Standard 2: Communicate Effectively - The district and its schools support staff to engage in proactive, timely, and two-way communication so that all families can easily understand and contribute to their child's educational experience.

Standard 3: Support Student Success - The district and its schools build the capacity of families and educators to continuously collaborate to support students' academic, social, and emotional learning.

Standard 4: Speak Up for Every Child - The district and its schools affirm families' and students' expertise so that all students are treated fairly and have access to relationships and opportunities that will support their success.

Standard 5: Share Power - The district and its schools partner with families in decisions that affect children and families and together—and works as a team to inform, influence, and create policies, practices, and programs.

Standard 6: Collaborate with Community - The district collaborates with community organizations and members to connect students, families, and staff to expanded learning opportunities, community services, and civic participation.
