Survey Background

- District-wide biennial Family-School Partnership (FSP) survey
 - o Formerly known as the Welcoming Environment survey
 - o Re-designed in 2014-15 to align to new standards for family engagement




FSP-COVID Adjustments

- Modifications to the survey to reflect both remote and in-person environments.
- Questions were added about health and the learning models of the respondent's children.
- 17 questions were modified to allow responses that reflect 'when in-person' and 'when remote.'
- The 2020-2021 FSP questions can be found <u>here</u> and a detailed crosswalk of the modifications can be found <u>here</u>.



Participation

- Survey open from November 27, 2020 to January 4, 2021
- Available in eleven languages
- 9,329 responses in 2020-2021
- No paper option this year which can range for 1500 to 3000 surveys







Changes to any one of these factors can distort the picture






Winter Acadience Participation

- 97% of Jeffco K-3 students completed*
- Comparable to prior years
- Subgroup participation similar to Fall 2020

Acadience Considerations

- Significantly more students completed acadience in a remote setting
 - Different test setting for many students compared to BOY
 - Technology issues can disrupt testing experience








Acadience Overview by Grade









Winter Acadience Summary

- Significant progress in grade 1 from BOY to MOY
- Stable performance in grades 2 and 3
- Less than expected BOY to MOY progress for grade K and some student subgroups [IEP, ELL (NEP and LEP)]
- Jeffco performance is similar to other districts in CDE's Early Literacy Assessment Tool (ELAT) grant across Colorado

BOY: Beginning of year benchmark MOY: MIddle of year benchmark

IEP: Individualized Education Plan

ELL: English language learner NEP: Non English proficient ELL LEP: Limited English proficient ELL





MAP Considerations

- Delayed and extended test window (fall and winter)
- Remote administration for majority of students
- Lower participation = less complete picture of student performance on aggregate









2020 MAP Math Fall to Winter Performance




2020 MAP Math Fall to Winter Performance




2020 MAP Reading Fall to Winter Performance



Winter MAP Summary

- Math: stable or slight gains in high/high average
 - Math performance gaps slightly widened for IEP, ELL's (NEP and LEP) in most grades; FRL performance gap stable or slightly narrowing in most grades
- Reading: stable to slight decreases in high/high average
 - Reading performance gaps widened for ELL's (NEP and LEP) in nearly every grade
- Student median growth in math was relatively higher than growth in reading



JEFFCO DISTRICT ACCOUNTABILITY COMMITTEE RESOLUTION REGARDING SUSPENDING HIGH-STAKES TESTING

(March 2021)

WHEREAS the Jefferson County Public School's District Accountability Committee (DAC) believes that schools should be held accountable to the public for providing rigorous and effective academic programming for the students of Jefferson County Public Schools (the District); and,

WHEREAS the District Board of Education is dedicated to protecting the health and safety of all students, staff, and visitors to District schools and, to that end, is adhering to the recommendations and guidelines set from the Center for Disease Control, the Colorado Governor's office (the State), the Jefferson County Public Health Department, and the Colorado Department of Education (CDE) related to controlling the spread of the COVID-19 pandemic; and,

WHEREAS the pandemic crisis has led to a significant disruption in learning for all students in Colorado and the District; and,

WHEREAS students and teachers have dealt with increased uncertainty, anxiety, and stress in both the 2019-2020 and 2020-2021 school years; and,

WHEREAS students have missed valuable instructional learning time during the 2019-2020 and 2020-2021 school years; and,

WHEREAS the State has properly made the health and safety of all students and staff a priority during the pandemic; and,

WHEREAS the mental health of students and staff has been seriously and negatively impacted by stress and concerns related to the pandemic and would be unnecessarily exacerbated by mandatory high-stakes assessments this spring, particularly in light of the academic difficulties teachers and students are already facing due to the pandemic; and,

WHEREAS the DAC continues to value the District's local interim assessments that give actionable and immediate data to inform instruction, intervention, and learning loss, which could be used as data for assessing student academic growth during the critical time of the continuing pandemic;

NOW THEREFORE, BE IT RESOLVED that while the DAC supports a full suspension of the administration of the Colorado Measures of Academic Success (CMAS) state assessments for the 2020-2021 school year, we recommend that the Board comply with state and federal mandates for testing, with limitations to ensure the least amount of in-person testing possible and adjustments as allowed by a waiver submitted by the Colorado Department of Education, if approved; that the District's interim assessments be used for measuring student academic growth in the District's Unified Improvement Plan; and that the District comply with state law in notifying families about opting their children out of testing.
